

**ORDINANCE NO. 771**  
**SUPPLEMENTAL APPROPRIATION**

An Ordinance Entitled Ordinance No. 771, a Supplemental Appropriation  
for the City of Custer City, South Dakota, for the Fiscal Year 2015.

WHEREAS, the budget adoption process was already completed when the additional budget items were implemented, it is necessary to make, approve, and adopt a supplemental appropriation ordinance for the fiscal year commencing January 1, 2015, to supplement certain funds established by the Appropriation Ordinance No. 753 for the fiscal year 2015:

THEREFORE, BE IT ORDAINED by the Common Council of the City of Custer City:

SECTION I: That in addition to the sums of money appropriated by said Appropriation Ordinance No. 753, the following sums shall be appropriated, to-wit:

Capital Improvements (4312)	\$ 25,000
<b>BID FUND:</b>	<b>\$ 45,000</b>
<b>PROMOTION FUND:</b>	<b>\$ 20,000</b>
<b>WASTEWATER FUND:</b>	<b>\$ 80,000</b>
<b>TOTAL SUPPLEMENTAL APPROPRIATION</b>	<b>\$217,000</b>

SECTION II: that no levy shall be made for any part of said \$217,000 from the 2015 funds here-in-above stated.

SECTION III: that all ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION IV: that this ordinance, being an ordinance for the support of the municipal government and its existing public institutions, shall be in full force and effect immediately upon its passage and publication as provided by law.

SECTION V: that should any section or sections of this ordinance be declared invalid or unconstitutional by a Court of the last resort, the same shall not invalidate the remaining sections of this ordinance.
